Do you want to bring your 4-legged friend on holiday to Scalea with you?

Your pets will always be welcome at Santa Caterina Village. We happily welcome dogs, cats and pets such as rabbits, hamsters and similar, small in size (up to 10 kg), medium in size (up to 20 kg) and large in size (up to 40 kg).

For them we have thought dedicated routes to allow them to move in total safety and relaxation; furthermore, they can play and relax, giving vent to all its exuberance by running freely in the "Pet Zone" located in the pine forest near the Village pool.

At the moment we do not provide food supply but above all, for everyone's well-being, we only accept a limited number of animals.

Finally, the 4-legged holiday is governed by the following rules which must be explicitly accepted at the time of booking.

The cost for the stay of 4 legged friends, including the contribution for final cleaning of the room, is €10.00 per day for the small size up to 10Kg, €15.00 per day for the medium size up to 20Kg and of €25.00 per day for large breeds up to 40kg.

The service can be combined with any ongoing booking, subject to acceptance of the regulations and availability as we limit the total number of animals in the facility.

4-LEGGED HOLIDAYS REGULATIONS

At Santa Caterina Village, we happily welcome small-sized (up to 10 kg), medium-sized (up to 20 kg) and large in size (up to 40 kg), dogs, cats and pets such as rabbits, hamsters and similar. The 4-legged holiday is governed by the following rules which must be explicitly accepted at the time of booking and confirmed at check-in:

1. Pets are allowed with a maximum weight of 40 kg and equipped with a health card to be shown at check in and which certifies their good health and that the required mandatory vaccinations have been carried out.
2. Remember that you are solely responsible for the behavior of your pet and you have the obligation to maintain its well-being and cleanliness for the entire duration of your stay. If your "pet" causes damage to things or people or repeatedly disturbs the peace of other guests, the Management reserves the right to take all necessary measures to resolve the problem, including transfer to an external facility, although very reluctantly, and paid by the puppy's owner.
3. When you take your little four-legged friend around the village, remember that it is mandatory that it is always tied to a leash, that it is equipped with a shovel and waste collection bag and a muzzle to wear* where necessary (** for large ones always in elevators, on stairs or in corridors*).
4. Your puppy is welcome in the hotel and in many of its areas, however there are areas where he will never be able to access such as restaurants, bars, the umbrella and deckchair areas of the swimming pools and the children's playground, as required by ordinances municipal regulations in force.
5. Guide dogs and assistance dogs for disabled people are accommodated free of charge and without restriction of access to places, as required by current regulations.
6. Help us maintain high standards of cleanliness and therefore please contact our reception staff to agree the cleaning service hour, between 09.00 am and 12.00 noon, for the daily cleaning of your room. During the cleaning room have to be left by the guest and its pets.
7. The cost for the stay of the little friends, including the contribution for final cleaning of the room, is €10.00 per day for the small size up to 10Kg, €15.00 per day for the medium size up to 20Kg and of €25.00 per day for large breeds up to 40kg.
